Internet use affects patient care. While most

comforting, physicians may need to encourage
and safeguard patient autonomy and protect
patients from dubious information sources.

**Glossary:****CFACT**

Anosognosia source: Unawareness of illness, seen in some serious mental illness and neurological disorders according to X. Amador, PhD, Director of Psychology at NY Psychiatric Institute and Professor of Psychology at Columbia. A 1986 study by William H. Wilson, M.D. et al found 89 percent of patients with schizophrenia denied the illness. Amador et al found, in a 1994, study that nearly 60 percent of 221 patients with schizophrenia did not believe they were ill. He and coauthor Anna Johanson wrote *"I Am Not Sick, I Don't Need Help: a Practical Guide for Families and Therapists"* published in 2000, Vida press,

International:

Patients with schizophrenia and bipolar disorder are paid to take medication in a study at Queen Mary Hospital in London. The sum of about \$24 dollars per injection offered monthly is intended to encourage patients to avoid relapse and rehospitalization.

Such programs have been tried in patients with tuberculosis in the past. The bioethics issue raised, of course, is the question of coercion, but informed consent has always been a problem in patients who have diseases that may impair their reasoning capacity.
